**A RESOLUTION OF THE BOARD OF SUPERVISORS, TOWNSHIP OF LANCASTER, BUTLER COUNTY,
PENNSYLVANIA, TO APPOINT MEMBERS & ALTERNATE MEMBERS OF THE PLANNING
COMMISSION**

WHEREAS, Section 203 of the Pennsylvania Municipalities Planning Code (MPC), P.L.805, No. 247 cl. 53, permits the Board of Supervisors to appoint up to eight residents of a municipality to serve as primary members and alternate members of the Planning Commission; and

WHEREAS, the Township of Lancaster Board of Supervisors desires to appoint two residents of Lancaster Township as primary members of the Planning Commission; and

WHEREAS, primary members of the Planning Commission shall serve a term of office for four years.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of the Township of Lancaster, Butler County, Pennsylvania as follows:

Section 1. Ben Jezovnik, a current resident of Lancaster Township is re-appointed as a primary member of the Township Planning Commission to complete a four-year term of office, term ending 12/31/2026.

Section 2. Tim Greenlund, a current resident of Lancaster Township is re-appointed as a primary member of the Township Planning Commission to complete a four-year term of office, term ending 12/31/2026.

Section 3. Debbie Scott, a current resident of Lancaster Township is appointed as a primary member of the Township Planning Commission to complete a four-year term of office, term ending 12/31/2026.


Section 4. Scott Bruner, a current resident of Lancaster Township is re-appointed as an alternate member of the Township Planning Commission to complete a four-year term of office, term ending 12/31/2026.

Section 5. Jeff Miller, a current resident of Lancaster Township is re-appointed as an alternate member of the Township Planning Commission to complete a four-year term of office, term ending 12/31/2026.
