**A RESOLUTION OF THE TOWNSHIP OF LANCASTER, COUNTY OF BUTLER,
COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE ACCEPTANCE OF
BUTLER COUNTY CORONAVIRUS LOCAL FISCAL RECOVERY FUNDS (CLFRF)**

WHEREAS, the County of Butler was eligible to receive funding from the Coronavirus Local Fiscal Recovery Funds (CLFRF) of H.R. 1319 American Rescue Plan Act of 2021 (ARPA) directly from the U.S. Department of the Treasury; and

WHEREAS, the U.S. Treasury has issued guidance on the use of these funds; and

WHEREAS, the County has allocated a portion of the CLFRF funds to invest in the infrastructure needs of the County; and

WHEREAS, the County has created a Municipal Infrastructure Program (MIP) to provide CLFRF funds to local municipalities; and

WHEREAS, Lancaster Township submitted a request in the amount of \$215,000.00 to fund West Lancaster Road Culvert Replacement Project; and

WHEREAS, the County has awarded \$193,590.00 in CLFRF funds to assist with this Project; and

WHEREAS, as a sub-recipient of the CLFRF, Lancaster Township must comply with all applicable budgeting, accounting, contracting, reporting and other compliance requirements for all CLFRF funds.

NOW THEREFORE, BE IT RESOLVED, that Lancaster Township does hereby accept the CLFRF funds awarded by the County of Butler.

BE IT FURTHER RESOLVED, that by adopting this Resolution, Lancaster Township hereby certifies that there has been no breach of any Agreement (written or oral); payment obligation; or funding commitment to the County of Butler.

BE IT FURTHER RESOLVED, that C. Michael Foote, Manager/Secretary/Treasurer is hereby authorized, designated, and directed to take all actions deemed reasonably necessary on behalf of Lancaster Township to receive and administer the CLFRF funds in accordance with all applicable federal regulations, and guidance outlined by U.S. Treasury.




